4) Eligibility criteria for admission (Fulfilling all / applicable conditions mandatory):

- The candidate must have passed 10+2 or equivalent examination including International Baccalaureate Diploma with science or science vocational with Physics, Chemistry, and Mathematics (PCM) or Physics, Chemistry and Biology (PCB) and English as compulsory subjects and obtained minimum 45% marks in (PCM / PCB).
- 4.2 Any State-CET score will be accepted and should be passed for 2024 academic year.
- 4.3 If seats remain vacant after admitting CET candidate, the Non-CET candidate will be admitted on the basis of 10+2 or equivalent examination marks of PCM / PCB.
- 4.4 Candidate of CBSE / ICSE should mention in the online registration / e-admission form (if selected) 10+2 or equivalent aggregate marks of all the subjects for which the candidate has taken & appeared for (not best of four, five, six or seven). The candidate shall have passed all the subjects taken & appeared for in the applicable examination/s.
- 4.5 In case mark sheet issued by the applicable Board / Institution is in percentile/s, the actual aggregate percentage of all the subjects appeared by the candidate will be taken into consideration.
- 4.6 **For IB & Cambridge Candidate:** Candidates called for admission on the basis of merit list & who do not have final mark sheet will be given "Provisional Admission" based on predicted scores. Fees will be accepted from such candidate but their admission will be confirmed on submission of final mark sheet if found eligible before the commencement of the programme. - 4.7 Submission of AIU equivalence certificate to confirm the eligibility for the program is mandatory for those candidates who have completed their (10+2) examination from Overseas University.
- 4.8 Those candidates who have passed, or, are appearing for 10+2 examination from a Board / University where Grade Point Average is given, must produce in writing from the concerned Board / University about the equivalent percentage for the GPA / CGPA obtained.

- 4.10 Candidates above 25 years of age are not eligible to apply.
